# AMENDMENT NO. 1 TO BUREAU OF RECLAMATION CONSENT TO USE NO. 16-07-1U-L0224 Umatilla Basin Project, Oregon

THIS AMENDMENT is made and entered to thisday of,
2022, between the UNITED STATES OF AMERICA, acting by and through its Department of
the Interior, Bureau of Reclamation, hereinafter referred to as the United States, and Umatilla
<b>County</b> , a political subdivision of the State of Oregon, hereinafter referred to as the Grantee.

### WITNESSETH:

WHEREAS, on February 13, 2017, the United States entered into Consent to Use No. 16-07-1U-L0224 with the Westland Irrigation District, as Grantee, to allow the Grantee to own, install, operate, and maintain a 42-inch steel irrigation pipeline across the United States' right-of-way for the West Extension Main Canal; and

WHEREAS, the Westland Irrigation District has divested itself of the lands and all interests associated with the proposed irrigation pipeline; and

WHEREAS, Umatilla County, as the new owner, has a continued requirement for said pipeline in association with an ongoing water project; and

WHEREAS, it has been administratively determined that amendment of the contract to reflect the change in ownership and other conditions necessitated by the acquisition of the facilities by a public entity will be in the public interest and will not substantially injure the interest of the United States in the property affected.

**NOW THEREFORE**, in consideration of the premises and the mutual covenants and stipulations hereinafter states, the parties hereto do mutually agree, effective on the date of execution hereof, as follows:

- a. The following conditions are hereby modified:
- 1) The Granting Clause to the original contract is hereby amended to read as follows:
  - "... and Umatilla County, a political subdivision of the State of Oregon, hereinafter referred to as the Grantee."

- 2) Condition 5.a. is amended to read as follows:
- "The Grantee shall provide Reclamation's Umatilla Field Office and the District fifteen (15) days' notice of intent to commence construction and/or installation activities, and five (5) days' notice prior to entering the subject easement or premises for the purposes of construction and/or installation activities."
- **b.** The following conditions are added hereto to Condition 5 "Special Stipulations" and are made a part hereof:
  - "g. No construction, repair, or maintenance activities shall take place during the irrigation season (March 1 through October 31 of each year).
  - h. Construction hours shall be Monday through Friday between the hours of 7 a.m. and 5 p.m.
  - i. A key to the canal access gate will be provided to the Grantee's contractor during construction activities. The contractor shall ensure that the canal gate remains closed and locked during all non-construction hours.
  - j. The Grantee shall conduct an inspection of its facilities prior to February 1 of each year and provide a letter of inspection and current emergency contact information to the District."

ALL OTHER TERMS AND CONDITIONS SHALL BE AND REMAIN THE SAME.
