SUBJECT: Authorization to Purchase Exhibit Space and Development of Marketing Materials for Attendance at Data Center World Conference

<p>Background: The Community Development Department seeks approval to utilize Economic Development funds to purchase trade show exhibit space and attend the Data Center World Conference in Washington, DC to be held in April, 2024. The fee for conference registration and trade show exhibit space is \$13,500. In addition, the department requests entering into contract with Duke Joseph Agency in the amount of \$7,550 to assist with the development of a trade show display and informational marketing materials. 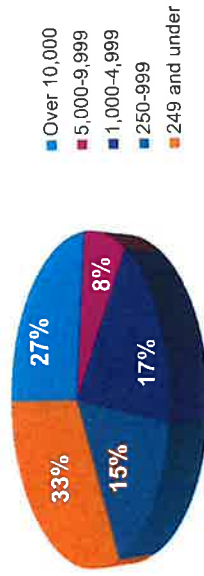

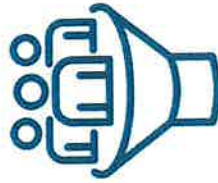

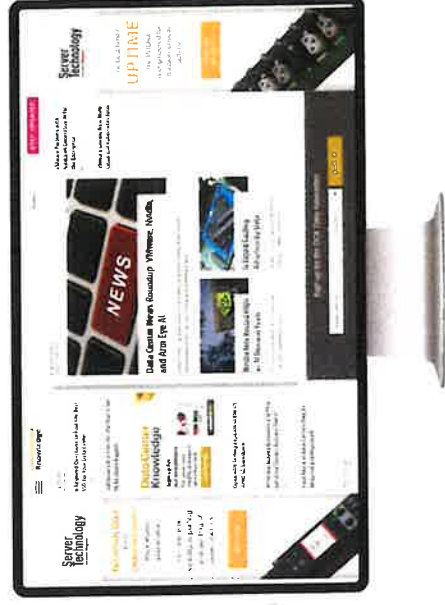

### **Trade Show Elements**

Umatilla County plans to participate in the Data Center World Conference April 16-18, 2024 in Washington DC. The county is procuring a 10x10 booth space in the BUILD portion of the conference, along with industry partners. Duke Joseph proposes to create the following elements to enhance the booth space, and help market the County as a potential location for data center development.

1. 4-PAGE FULL-SIZE COLOR BROCHURE that encapsulates all of the selling points of the region, relevant statistics, attractive photography, and 'next steps.' Every interested person can be given this one simple tool to remember Umatilla County by once they leave the conference. The brochure will also be available in digital format for online contacts and visitors to the UC website. The digital brochure will have live links and embedded videos to seamlessly present additional content.
2. 60-SECOND LOOPED REEL formatted for a trade show monitor, featuring beautiful photography of Umatilla County - the farmlands, cities, solar energy, construction, etc. as well as simple maps and engaging subtitles. Images from the brochure will be included, to tie it all together as one message. The reel can be interrupted, so other visuals and information can be pulled up on the monitor.
3. EYE-CATCHING VERTICAL BANNER with a simple message to grab the attention of those visitors approaching the trade show booth from the opposite direction of the monitor. Banner image will correlate with the brochure and the monitor reel.

Deliverables include custom photography, video, graphics, layout, formatting and printing. Drafts of all 3 elements will be submitted for approval by March 30, before final execution April 9.

## **Umatilla County Economic Development Video**

Umatilla County would like a video featuring the selling points of the county, directed toward those considering moving to - and establishing business - in Eastern Oregon, but one that would appeal to locals as well. Duke Joseph proposes to create and deliver a fresh, forward-looking video that hits on all of the strong points of the county - the beauty, affordability, available land, high-tech bent, and business-friendly attitude that Umatilla County embraces. Most importantly the video would highlight the welcoming and affable nature of the people of the county - easy to work with, pleasant to run into, rewarding to hire.

The video would feature a local personality to narrate the story, with cutaways, animations and maps that seamlessly and logically tell the viewer what he/she can expect from the product that is Umatilla County. There would be a Developer or two, and a County representative showing them around, which would give continuity and purpose to the storyline.

Final Product: Full length 3-5 minute video, and a corresponding one-minute spot.

Deliverables include original video footage, custom photography, graphics, animation, tagline, music score, editing, narration copy, narrator, casting, wardrobe, props.

Tagline, music, and storyboards will be submitted for approval by May 15.

A rough draft version will be submitted for approval by June 14.

Final video will be delivered by June 28 in MOV format.
