SUBJECT: Body Armor

<p>We need new and replacement body armor for several deputies, due to on-going new hires and expiration/wear and tear issues of current Deputy's equipment. Body armor is a required piece of critical safety equipment for law enforcement. All body armor has an expiration date per manufacturers, so this is a recurring need. The body armor listed is consistent with our current uniform standard issue. We are using a different supplier for this order, due to changes in personnel and complications with past orders with our previous supplier. The pricing between the two vendors has been consistent. The body armor quote (attached) is equipment for the Criminal and Corrections Divisions. We been awarded grant money in a Federal reimbursement program, for which we will receive reimbursement for 50 % of our body armor costs. Our award total is \$31,466.02. Our previous order and this order both fall within the time-frame to be eligible for us to request reimbursement.
