WHEREAS the Board of Commissioners has adopted a Comprehensive Plan for Umatilla County;

WHEREAS pursuant to Chapter 660, Division 12, of the Oregon Administrative Rules, and specifically OAR 660-12-0045, Umatilla County, as part of its Comprehensive Plan, adopted by Ordinance No. 2002-03, a Transportation System Plan for Umatilla County ("TSP); and

WHEREAS as part of the Barnhart Road-Airport Road Connector project of the City of Pendleton, an Interchange Area Management Plan was conducted and prepared in May 2007 by Kittelson & Associates for the I-84/Barnhart Road Interchange ("IAMP") to ensure that the interchange area continues to operate and to function as designed with the new connection between Barnhart Road and Airport Road;

WHEREAS the county is proposing to amends its TSP to add the Interchange Area Management Plan;

WHEREAS the Umatilla County Planning Commission held a public hearing on May 17, 2007 to review the Interchange Area Management Plan and the proposed amendment to the TSP and the Umatilla County Comprehensive Plan and recommended that the Board of Commissioners adopt the IAMP and the amendment;

WHEREAS the Board of Commissions held a public hearing on June 6, 2006, to consider the proposed amendment, and voted to approve the IAMP and the amendment.

NOW, THEREFORE the Board of Commissioners of Umatilla County ordains that the I-84 Barnhart Road Interchange Area Management Plan is accepted and adopted, and the Umatilla County Transportation System Plan and the Umatilla County Comprehensive Plan are amended to include the Interchange Area Transportation

Plan. A copy of the Interchange Area Transportation Plan is attached to this ordinance and incorporated by this reference.

FURTHER by unanimous vote of those present, the Board of Commissioners deems this Ordinance necessary for the immediate preservation of public peace, health, and safety; therefore, it is adjudged and decreed that an emergency does exist in the case of this Ordinance and it shall be in full force and effect from and after its adoption.
