ORIGINAL LEGAL DESCRIPTION

From this corner the Leinbach property was then located using the calls in the deed recorded in Book 152 at page 137, Records of Unatilla County, Oregon. For the purposes of this survey the right of way centerline of County Road No. 717 was held at the as-built road centerline. See the Boundary Line Adjustment map recorded
