I CERTIFY THAT I HAVE CORRECTLY SHOWN AND MONUMENTED PARCELS 1 AND 2 OF THIS PARTITION PLAT IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED, AND CITY OF PENDLETON AND UMATHLA COUNTY DEVELOPMENT ORDINANCES. MONUMENTS WERE RECOVERED OR ESTABLISHED AS NOTED ON THIS PARTITION PLAT.

EXISTING MONUMENTS FOUND, HELD, AND SET ARE NOTED ON SHEET 1 OF THIS PARTITION PLAT. THE CENTERLINE OF S.E. 15TH DRIVE WAS CALCULATED BY HOLDING THE "PK" NAIL AT THE CENTERLINE INTERSECTION OF S.E. BYERS ASKULE AND S.E. 15TH DRIVE. AND A INAIL FOUND AND SHOWN IN THE DETAIL ON SHEET 1 OF THIS PARTITION PLAT. THIS NAIL IS NOT LOCATED AT THE CENTERLINE INTERSECTION OF S.E. 15TH DRIVE. AND S.E. ALEXANDER PLACE, BUT CONTROLS ALICAMENT OF S.E. 15TH DRIVE. THE CENTERLINE OF S.E. ALEXANDER PLACE WAS HELD AS CALCULATED AT ON PARTITION PLAT 1933—08. RELATIVE OF RESERVE ADDITION MONUMENTS 8 AND 14 IN THE CENTERLINE OF S.E. COURT PLACE. THE CENTERLINE OF S.E. 16TH STREET AND S.E. ALEXANDER PLACE WAS CALCULATED AT A 9000'00" ANDLE AND A DISTANCE OF 120.5.00 FEET FROM THE INTERSECTION OF S.E. 16TH STREET AND S.E. COURT PLACE, AS SHOWN ON PARTITION PLAT 1033—08.

BLOCK 11 OF BYERS PARK ADDITION WAS LAID OUT HOLDING RECORD DISTANCES ALONG THE EAST AND MEST SIDES OF THE BLOCK, PER THE ORIGINAL PLAT OF BYERS PARK ADDITION.
