

### SURVEYOR'S CERTIFICATE

I, Jeffrey S. Hsu, Registered Professional Land Surveyor, hereby certify that I have surveyed and platted Parcels 1, 2 and 3 of this partition, situated in the Northeast guarter of Section 14. Township 5 South. Range 31 East of the Willamette Meridian, City of Ukiah, Umatilla County, Oregon, more particularly described as follows,

Beginning at a point on the South right of way line of Waid Street, from which the Center quarter corner of said Section 14 bears South 66"23'27" West, a distance of 927.60 feet,

Thence: North 59°42'51" East, along said South line, a distance of 217.78 feet,

Thence: South 0°17'33" West, a distance of 240.81 feet, to the North right of way line of State Highway No. 244, said being a point on a spiral curve to the

Thence: Along said spiral, being parallel and 40 feet distant from centerline spiral with a central angle (S-value) of 16'00', and a a-value of 2.0, a distance of 115.69 feet, (the long chord which bears South 56'48'02" West, a distance of 115.59 feet) to the point of curvature of a 676.20 foot radius curve to the

Thence: Along said curve a distance of 100.49 feet, through a central angle of 8'30'53" (the long chord which bears South 65'26'11" West, a distance of 100.40

Thence: North 077'33" East, a distance of 236.01 feet, to the Point of Beginning of this description.
