THIS SURVEY WAS MADE AT THE REQUEST OF CLIFF BRACHER TO PARTITION TWO SMALLER HOUSE PROPERTIES OFF OF A LARGER TRACT OF LAND. PARCELS 1 AND 2 ARE SURVEYED AND PARCEL 3 THE REMAINDER IS UNSURVEYED. ALL MONUMENTS FOUND AND HELD ARE NOTED. AS SHOWN THE SOUTHERLY BOUNDARY OF PARCELS 1 AND 2 IS THE NORTHERLY RIGHT OF WAY LINE OF OF COLD SPRINGS HIGHWAY. THE COLD SPRINGS BRIDGE WAS REPLACED IN THE EARLY 1990'S AND NEW RIGHT OF WAY WAS ACQUIRED AS SHOWN ON SURVEY NO. 91-106-C, ALONG WITH A NEW CENTERLINE ALIGNMENT ALONG A PORTION OF THE SURVEYED PARCELS. I RECREATED THE OLD ALIGNMENT HOLDING MONUMENTS FOUND FROM SURVEY NO. 91-106-C. SEE NOTE TABLE FOR FURTHER DETAILS. THIS SURVEY WAS MADE WITH A TWO PERSON CREW USING A TRIMBLE 5700 SERIES GPS RECEIVERS OPERATED IN REAL TIME KINEMATIC MODE.


