
# BOUNDARY LINE ADJUSTMENT SURVEY

## SURVEYORS NARRATIVE

THIS SURVEY REQUESTED BY BERNARD AND NADINE VAN MECHELEN IS TO IDENTIFY AND DESCRIBE THE NEW PROPERTY LINES AND NEW ACREAGES OF THE TAX LOTS SHOWN ON THIS MAP, TAX LOTS 800 AND 803 AS DESCRIBED BY WARRANTY DEED RECORDED ON REEL 62-1745, UMATILLA COUNTY RECORDS. THIS SURVEY IS LOCATED IN EAST I/2 OF THE N.E. I/4 OF THE S.E. I/4, SEC. 3, T.2N. R.33 E.W.M. UMATILLA COUNTY, OREGON.

BECAUSE OF THE POOR CONDITION OF THE MONUMENTATION IN THIS 1/16 th SECTION 1 ACCEPTED AND HELD THE FOUND PINS OF OF MNP-92-02 / CS \* 92-107-C AS THE BEST EVIDENCE OF THE NORTH-SOUTH CENTERLINE, AND SOUTH LINE OF SAID 1/16th SEC. WHICH I USED AS CONTROLLING THE PINNED CORNERS OF THE NEW TAX LOTS. A TOPCPN GTS-2B GEODETIC TOTAL STATION WAS USED ON THIS SURVEY.
