NARRATIVE OF SURVEY

THE PURPOSE OF THIS SURVEY WAS TO DIVIDE TRUST ALLOTMENT T-2010, INTO 3 PARCELS UNDER THE CONFEDERATED TRIBE'S "PLANNED UNIT DEVELOPMENT" REGULATIONS.

THE SURVEY WAS MADE WITH A SOKKIA SET 4B FIVE SECOND TOTAL STATION WITH A 2 PERSON CREW. THE SURVEY WAS MADE BY A COMBINATION OF OPEN TRAVERSE WITH RADIAL TIES AND BY CLOSED TRAVERSE. ANGLES AND DISTANCES WERE DOUBLED WHEN TYING CONTROL TRAVERSE POINTS OR MONUMENTS AND WHEN SETTING
