
RECORD OF SURVEY

NARRATIVE OF SURVEY

THIS SURVEY WAS MADE AT THE REQUEST OF THE CONFEDERATED TRIBES OF THE UMATILLA INDIAN RESERVATION AND BY MR. LES MINTHORN. THE PURPOSE OF THE SURVEY WAS TO MONUMENT THE EXTERIOR BOUNDARY OF CTUIR'S RECENTLY PURCHASED LANDS IN SECTION 16, T1N., R33E., W.M., AND ALLOTMENT C-65A, OWNED BY MR. LES MINTHORN.

CORNER POSITIONS ON THE INTERIOR OF THE SECTION WERE SEARCHED AND RE-ESTABLISHED BASED ON THE "THREE MILE RULE" OF SECTION SUBDIVISION, PER ALLOTMENT SURVEYS BY JAMES CURRIN. THE INTERIOR OF THE SECTION HAS BEEN FARMED EXTENSIVELY AND NOTHING REMAINS OF THE STONE CORNER MONUMENTS REPORTED BY CURRIN. C.E. REDFIELD, U.S. INDIAN SERVICE SURVEYOR, PERFORMED ALLOTMENT SURVEYS BETWEEN 1917 AND 1921 OVER PORTIONS OF THE UMATILLA INDIAN RESERVATION. REDFIELD'S MONUMENTS WERE TYPICALLY BRASS CAPS ON 2 BY 36 INCH IRON PIPES. ALTHOUGH NO RECORD OF SUBSEQUENT RECOVERY OR RE-ESTABLISHMENT OF CORNERS IN THE INTERIOR OF SECTION 16 WAS FOUND IN AVAILABLE C.E. REDFIELD NOTES, WE SEARCHED REQUIRED CORNER POSITIONS WITH METAL DETECTOR, BECAUSE PORTIONS OF THE REDFIELD NOTES COULD BE LOST. EVIDENCE OF C.E. REDFIELD RE-SURVEYS AND MONUMENTATION WAS FOUND AT THE NORTHWEST, NORTHEAST AND SOUTHEAST CORNERS OF SECTION 16, IN THE FORM OF WITNESS CORNER MONUMENTS.

THE SURVEY WAS MADE WITH TRIMBLE 5700 SERIES GEODETIC G.P.S. RECEIVERS OPERATED IN REAL TIME KINEMATIC MODE. CORNER SEARCHES WERE MADE WITH A TRIMBLE PRO-XR BEACON CORRECTED G.P.S. UNIT. A STEEL TAPE AND COMPASS WAS USED TO MEASURE TO ACCESSORIES REPORTED ON CORNER RECORDS.
