


NARRATIVE:

THIS SURVEY WAS MADE AT THE REQUEST OF HAROLD AND KATHARINA WALKER. THE PURPOSE OF THE SURVEY WAS TO SURVEY AND MARK THE SOUTH, EAST AND NORTH LINES OF THE SW1/4 OF THE SW1/4 OF SECTION 26 AND THE WEST LINE OF THE NW1/4 OF THE SW1/4 OF SECTION 26. STEEL FENCE POSTS WERE SET ON THE PROPERTY BOUNDARY AT RANDOM INTERVALS OF APPROXIMATELY 150 TO 200 FEET. THE SW 1/16TH CORNER OF SECTION 26 AN THE S 1/16TH CORNER COMMON TO SECTIONS 26 AND 27 WERE ALSO ESTABLISHED AND MONUMENTED, AS INDICATED. THERE IS A CROOKED FENCE LINE NEAR THE MARKED PROPERTY LINE BOUNDARY. THE FENCE IS NOT MAINTAINED AND IS IN POOR CONDITION.

CONTROL POINTS FOR THE SURVEY WERE ESTABLISHED WITH TRIMBLE 5700 SERIES GEODETIC GPS RECEIVERS OPERATED IN STATIC MODE. TIES TO CONTROLLING CORNERS WERE MADE WITH A SOKKIA SET 48 FIVE SECOND TOTAL STATION FROM G.P.S. CONTROL POINTS. THE TRAVERSE OF THE BOUNDARY LINE MARKED WITH STEEL FENCE POSTS WAS MADE BY TOTAL STATION TRAVERSE.
