

DEDICATION AND RESTRICTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS, that the undersigned persons, being Owners of the real property duly platted as Skyview Memorial Park, Umatilla County, State of Oregon, hereby make the following declarations as to limitations, restrictions, dedications and uses to which all of the said Addition and each part thereof may be put:

HEREBY specifically, that said declarations shall constitute the dedications and covenants and will run with all the land as provided by law and hereby declare that the general scheme and plan is now hereby impressed and fixed upon all of the said Addition and each part there;

THAT all of the dedicators successors, representatives and assigns shall take title subject to such general scheme and plan even though no reference to such plan shall be made in any Cemetery Deed or Conveyance or to any successor, representative or assign;

(1) That all the land within the boundaries as delineated on the accompanying plat is to be used for cemetary purposes exclusively and perpetually.

(2) THAT we, the undersigned Owners, do hereby grant and dedicate to the public the roads, lanes and walks show on the accompanying plat to be so used as roads, lanes, and Walks forever.
