



## "PROPERTY" DESCRIPTION

Beginning at point of intersection of Northerly line of S.E. Byers Avenue and Westerly line of S.E. 2nd Street in Original Town, now Avenue and Mesterly line of S.E. 2nd Street in Original Town, now City of Pendleton; thence North 23°36' West along Westerly line of S.E. 2nd Street a distance of 200 feet; thence Southwesterly at right angles a distance of 125 feet; thence Southeasterly at right angles a distance of 200 feet to a point on Northerly line of S.E. Byers Avenue; thence Northeasterly along Northerly line of S.E. Byers Avenue a distance of 125 feet to the point of beginning.

Said lands also being described as Lots 2, 3, 4 and 5 and East 25 feet of Lots 6, 7, 8 and 9, Block 19, Original Town, now City of Pendleton, Umatilla County, Oregon.
