## WARRANTY DEED

This Indenture Witnesseth, That I, LILLIAN SAUNDERS, a widow, grantor, for the consideration of the sum of TWENTY-FIVE and 50/100 (\$25.50) DOLLARS, to me paid, have bargained and sold and by these presents do bargain, sell and convey unto the State of Oregon the following described premises, to-wit:

A parcel of land, being a portion of the following described property: The NW<sup>1/4</sup> of the NE<sup>1/4</sup> of Sec. 11, T. 4 N. R. 35 E. W. M., Umatilla County, Oregon; the said parcel being all that portion of the foregoing described property included in a strip of land 10 feet in width parallel to and adjoining the easterly right of way line of the Oregon-Washington highway as constructed over and across said property, and being more particularly described as follows:

Beginning at a point which is the intersection of the south line of said property with the easterly right of way line of the said highway; said point being 30 feet distance from (and measured at right angles to) the center line of said highway at engineer's station 239 + 61.2 said point also being 1340 feet north and 2765 feet east of the west 1/4 corner of said Sec. 11; thence N. 89 deg. 10' E. a distance of 10.4 feet; thence N. 17 deg. 29' W. a distance of 147.3 feet; thence on a 533 ft. radius curve to the right (the long chord of which curve bears N. 8 deg. 07' W.) a distance of 174.3 feet; thence N. 1 deg. 15' E. a distance of 400.5 feet; thence N. 88 deg. 45' W. a distance of 10 feet to the easterly right of way line of said highway; thence along said highway right of way line S. 1 deg. 15' W. a distance of 400.5 feet; thence on a 543 ft. radius curve to the left (the long chord of which curve bears S. 8 deg. 07' E.) a distance of 177.5 feet; thence S. 17 deg. 29' E. a distance of 144.3 feet to the point of beginning; containing 0.17 acres.

TO HAVE AND TO HOLD the said premises, with the appurtenances, unto the said State of Oregon, its successors, heirs and assigns forever.

And I, the said grantor, do hereby covenant to and with the said State of Oregon, its successors,

heirs and assigns, that I am the owner in fee simple of said premises; that they are free from all incumbrances,

and that I will warrant and defend the same from all lawful claims whatsoever.
