of the County of Umatilla, in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Fourteen Hundred Eighty-five (\$1465.00) Dollar paid him, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land _____ feet wide, being _____ feet on either side of the center line of said road, as surveyed over and across.

All that part of the property of L.D.Wilsey in the East $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Sec.14, T. 4 N.R. 35 E.W.M., included in a strip of land 60 ft. in width, being 30 feet on each side of the center line of the Oregon Washington Highway No. 8, as surveyed over and across said property and more particularly described as follows:

Beginning at a point approximately 1325.5 feet East and 345.0 feet North of the $\frac{1}{4}$ Sec. corner between sections 14 and 15 T. 4 N.R. 35 E.W.M. Umatilla County, State of Oregon; thence on a 10° curve to the left whose central angle is 44° 00'; 409.3 feet; thence North 23° 56' East 2193.6 feet to a point approximately .72.0 feet West of the $\frac{1}{4}$ Sec. corner between sections 11 and 14, T. 4 N.R. 35 E.W.M., said tract of land containing 3.56 acres of land, more or less.
