WARRANTY DEED.

THIS INDENTURE WITNESSETH, That we, W. H. FRAZIER and FRANCES FRAZIER, husband and wife, Grantors, for the consideration of the sum of SEVENTY-EIGHT and No/100 (\$78.00) Dollars to us paid, have bargained and sold and by these presents do bargain, sell and convey unto the STATE OF OREGON, the following described premises, to-wit:
