of one ~~one~~ Dollarpaid to her the receipt whereof is hereby acknowledgedhas granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A strip of land sixty feet wide being thirty feet on each side^x the center line of the Despain Gulch Market Road as surveyed over and across the Northwest Quarter of Section 11, Township 3 North, Range 31 East, W.M. and as more particularly described as follows:

Beginning at a point on the Section line 362.3 feet North of the center of Section 11 Township 3 North, Range 31 East, W.M. which point is known and designated as station 253/18.9 P.O.T. thence North 59°33' West 743.3 feet, thence on a 955.0 foot radius curve left 329.2 feet, thence North 79°18' West 728.0 feet, thence on a 1910.0 foot radius curve right 351.1 feet, thence North 68°46' West 696.6 feet to a point known and designated as station 281/67.1, said point being 1360 feet North of the Quarter Section corner common to sections 10, and 11 Township 3 North, Range 31 East W.M.
