John and Marjorie Walchli, Grantors, convey to Umatilla County, a political subdivision of the State of Oregon, Grantee, the following described real property for road right of way:

PARCEL A

A parcel of land located in the Southwest 1/4 of Section 9, Township 4 North, Range 29 East of the Willamette Meridian being more particularly described as follows:

Commencing at the brass-capped monument marking the corner common to Sections 8, 9, 17, and 16, T. 4 North, Range 29 E.W.M.; thence N89°03'52"E, 30.01 feet to the intersection of the easterly right of way line of South Edwards Road and the south line of Section 9 and the true point of beginning of this description; thence N0°22'35"E, 15.56 feet; thence N89°54'08"E, 977.62 feet; thence N89°59'35"E, 77.48 feet to the south line of said Section 9; thence S89°03'52"W, 1055.34 feet to the point of beginning. Said parcel contains 0.19 acre, more or less.

PARCEL B

A parcel of land located in the Southeast 1/4 of Section 9. Township 4 North, Range 29 East of the Willamette Meridian being more particularly described as follows:

Commencing at the Southwest 1/4 of Section 9, T. 4 North, Range 29 E.W.M.; thence N89°03'52"E, 4599.78 feet along the south line of said Section 9 to the true point of beginning of this description; thence N88°29'27"E, 606.36 feet; thence N86°33'57"E, 23.02 feet to the east line of Section 9; thence S0°16'21"W, 6.30 feet along the east line of Section 9 to the south line of Section 9; thence S89°03'52"W, 629.22 feet along the south line of Section 9 to the point of beginning. Said parcel contains 0.05 acre, more or less.
