A parcel of ground for highway purposes located in the N.E. $\frac{1}{4}$  of the NW $\frac{1}{4}$  of  
Section 1 Township 5 S. R. 33 E. W. M., more particularly described as begin-  
ning at a point 3947.1 feet north of and 408.1 feet west of the  $\frac{1}{4}$  corner  
between sections 1 and 12 Township 5 S.R. 33 E. W. M. thence around a 530.0  
foot radius curve to the left the long cord of which bears N. 26° 29' W.  
a distance of 640.6 feet more or less to the South right of way line of the  
Forest Road up Camas Creek, thence in a S. E. Direction and following the  
Southerly right of way line of the Forest Road up Camas Creek a distance  
of 623.0 feet more or less to a point, thence around a 100 foot radius  
curve to the left the long cord of which bears S. 64° 46' W., a distance  
of 197.7 feet, thence S. 8° 8.5' W. a distance of 93.0 feet more or less to  
the East and West subdivisional line between the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  and the
