NARRATIVE

The section breakdown was taken from Krumbein's Surveys #Mells-B and #M73-B and Haldard Survey S-links, Centralling corners are the 1" iron pin at the East Quarter corner of Section 29 and Krumbein's pins found on the East line of Northeast Quarter of the Southeast Quarter and on a line permillal to eadd Hast line and 200 feet West, I used the centerline stripe of the highway at Beaket Mountain Road and Krumbein's pin at the Northearly right of vey line at the interaction of the East line of Section 29. Mr. Clutter wented to buy a 50' strip mollium, so this stri was divisied off with this survey. The Northerly line of this 30' strip coincides with Clutters North femce line, but with this desceid North line.
