PURPOSE OF THIS PARTITION PLAT IS TO DIVIDE INTO THREE PARCELS A 4.53 ACRE TRACT BELONGING TO BILL COLE AS RECORDED ON PAGE 1454 OF ROLL 246 OF THE UMATILLA COUNTY DEED RECORDS. THIS DESCRIPTION IS FROM A SURWEY DONE BY AMBROES SHEA, C.S. NO. 1-62A. I FOUND THE PINS SET BY SHEA ALONG THE NORTHERLY LINE AND HELD THEM FOR LINE ALONG THE NORTHERLY SIDE. THE WESTERLY LINE HAS BEEN REDEFINED BY THE FURCHASE BY THE GISHD OF AN ADDITIONAL 35 FEET, AND THE EAST LINE IS REDEFINED BY AS UNVEY BREAKING DOWN THE SECTION BY DENNY EDWARDS IN 1985 FOR THE CITY OF HERMISTON.

BEARING ARE BASED UPON TIES TO PARTITION PLAT NO. 1994-17 BY DENNY EDWARDS AS SHOWN. THE EAST LINE WAS COMPUTED FROM EDWARDS SURVEY INFORMATION.

THERE ARE NO WATER RIGHTS APPLICABLE TO THIS PARCEL.
