### SURVEYORS NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO PARTITION TRACT I OF THAT PROPERTY DEEDED TO DUNN AND McCLANNAHAN RECORDED IN BOOK 331. PAGE 17 INTO THREE PARCELS. PARCEL ONE LIES WEST OF A 50 FOOT STRIP DEEDED TO C AND B LIVESTOCK AND IS LARGER THAN 10 ACRES SO WAS NOT SURVEYED. PARCELS 2 AND 3 LYING EAST OF SAID 50 FOOT STRIP WERE PARTITIONED ACCORDING TO TWO BUYERS


I SURVEYED THE EAST LINE OF THIS PROPERTY IN A 1977 SURVEY FOR O.R.C.O. IN THAT SURVEY I USED MONUMENTS FROM A 1976 KRUMBEIN SURVEY IN WHICH HE SUBDIVIDED THE SECTION. IN MY 1989 AREA ONE SURVEY FOR UMATILLA COUNTY I RESET THE SE CORNER OF SECTION 13 A DISTANCE OF 12.48 FEET EAST OF THE SECTION CORNER WHICH WAS SET IN 1972. SURVEYS THAT USED THE 1972 MONUMENT MISSED APPARENT PROPERTY LINES AND FENCE LINES TO THE WEST AND CAUSED MANY COURT CASES AND BOUNDARY LINE ADJUSTMENTS. WHEN MY NEW SECTION CORNER IS USED FOR A NEW SECTION BREAKDOWN. EXISTING FENCES FIT MUCH CLOSER AS IS THE CASE OF THE MOST SOUTHERLY NE CORNER OF PARCEL # 2 WHICH NOW FALLS IN AN OLD FENCE LINE.
