

SURVEYOR'S CERTIFICATE:

I. G. DENNIS EDWARDS. AM A REGISTERED SURVEYOR OF THE STATE OF OREGON AND HAVE MARKED WITH LEGAL MONUMENTS THE LAND SHOWN ON THIS PLAT.

THE PURPOSE OF THIS SURVEY IS TO PARTITION TWO PARCELS OUT OF THE ECHO GOLF COURSE PROPERTY FOR FUTURE SALES AND POSSIBLE SUBDIVISIONS. MOST OF THE BOUNDARY OF THIS PARCEL WAS PREVIOUSLY MONUMENTED EXCEPT FOR THAT PORTION LYING BETWEEN THE GOVERNMENT CANAL AND THE FEED CANAL. I ALSO HAD TO REPLACE MANY OF THE MONUMENTS AROUND "CLUB ADDITION" WHICH HAVE BEEN OBLITERATED.

THIS PROPERTY IS DESCRIBED IN DEEDS RECORDED IN BOOK 136. PAGE 578. BOOK 202. PAGE 410. AND ON REEL 227. PAGE 948. UMATILLA COUNTY DEED RECORDS. AND IS MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A BRASS CAP MARKING THE NORTHEAST CORNER OF SECTION 16. TOWNSHIP 3 NORTH. RANGE 29 EAST. WILLAMETTE MERIDIAN. UMATILLA COUNTY. OREGON. WE ALSO DEDICATE TO THE PUBLIC. THAT PORTION OF GOLF COURSE ROAD (A ROAD DESCRIBED ON REEL I3. PAGE. 671. UMATILLA COUNTY DEED RECORDS) WHICH RUNS FROM THE SE CORNER OF THIS PROPERTY WESTERLY TO AN IRON ROD WHICH MARKED WHAT USED TO BE THE CORNER COMMON TO LOTS 21 AND 22 OF "CLUB ADDITION". WE ALSO DEDICATE AN ACCESS EASEMENT 50 FEET WIDE WITH A 50 FOOT CUL-DE-SAC THROUGH THE MIDDLE OF PARCEL 2. AS SHOWN. FOR THE USE OF PARCELS 2 AND 3.
