SURVEYOR'S CERTIFICATE & NARRATIVE:

I, G. DENNIS EDWARDS, AM A REGISTERED SURVEYOR OF THE STATE OF OREGON, AND HAVE MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THIS PLAT.

THE PURPOSE OF THIS SURVEY IS TO PARTITION THAT TRACT OF LAND DEEDED TO JAMES G. AND DONNA L. CONNER ON REEL 9 PAGE 381, UMATILLA COUNTY DEED RECORDS, INTO THREE PARCELS EACH CONTAINING AN EXISTING HOUSE FOR POSSIBLE FUTURE SALES. THE HOUSE ON PARCEL 1 ENCROACHES ON THE IRRIGATION EASEMENT AND WILL BE REMOVED AND A NEW HOME POSSIBLY ERECTED AS SHOWN.

KRUMBEIN SURVEYED THIS TRACT IN A 1974 SURVEY FOR CONNER. I FOUND THE SE CORNER ABOUT 1 FOOT DEEP AND SET A NEW 5/8" AT THE SURFACE. I DID NOT USE HIS NW CORNER BECAUSE IT DOES NOT MATCH THE DEEDS. I USED MONUMENTS FROM THE PLAT OF "ALDER COURT" FOR THE WEST LINE OF THIS

DESCRIPTION: BEGINNING AT A POINT ON THE NORTH SOUTH CENTER LINE OF SECTION 10, T 4 N , R 28 E, WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON WHICH LIES 120.00 FEET NORTH OF THE CENTER OF SAID SECTION 10 AND RUNNING; THENCE NORTH ALONG SAID CENTER LINE 160.00 FEET; THENCE WEST PARALLEL WITH THE EAST WEST CENTER LINE OF SAID SECTION 10 A DISTANCE OF 330.00 FEET TO A POINT ON THE WEST LINE OF THE EAST 1/2 OF THE SE 1/4 OF THE SE 1/4 OF THE NW 1/4 OF SAID SECTION 10; THENCE SOUTH ALONG SAID WEST LINE 100.00 FEET; THENCE EAST PARALLEL WITH SAID EAST WEST CENTER LINE OF SAID SECTION 10 A DISTANCE OF 175.00 FEET MORE OR LESS TO A POINT WHICH LIES 155.00 FEET WEST OF THE NORTH SOUTH CENTER LINE OF SAID SECTION 10; THENCE SOUTH PARALLEL WITH SAID NORTH SOUTH LINE 60.00 FEET; THENCE EAST 155.00 FEET TO THE POINT OF BEGINNING. CONTAINING 42,291 SQUARE FEET (0.97 ACRES).
