

SURVEYORS CERTIFICATE AND NARRATIVE

I CERTIFY THAT I HAVE CORRECTLY SHOWN AND MONUMENTED PARCEL 1 OF THIS PARTITION PLAT IN ACCORDANCE WITH ORS CHAPTER 92, AS REWISED AND THE UMATILLA COUNTY DEVELOPMENT ORDINANCE. PARCEL 1 IS SURVEYED AND MONUMENTED AS SHOWN ON SHEET 1 OF 2. PARCEL 2 IS UNSURVEYED, BUT SHOWN ORAPHICALLY ON THE WORNTY MAP ON SHEET 1 OF 2. AS ALLOWED UNDER CHAPTER 152.644(7) OF THE UMATILLA COUNTY DEVELOPMENT ORDINANCE.

THIS PARTITION SURVEY WAS MADE AT THE REQUEST OF DONALD D. AND HELEN HAMMINS TO PARTITION A PARCEL OF LAND. CONTAINING 4,00 ACRES, MORE OR LESS, FROM A LARGER TRACT OF LAND. THE RECORD DEED DOCUMENT USED IN PREPARATION OF THIS FLAT IS DEED RECORDED AT BOOK 312, PAGE 320, DEED RECORDS OF JUANTILLA COUNTY AND RECORDED AS INSTRUMENT NO. 1971—32794. THE DESCRIPTION WAS LATER MODIFIED BY REMOVAL OF THE WEST HALF OF THE SOUTHWEST QUARTER OF SECTION 21. THE AREA OF PARCEL 1 IS ACALQUATED BY SUBTRACTING PARCEL 1 AREA FROM THE TOTAL AREA REPORTED ON UMATILLA COUNTY TAX MAP 10. 4432.

THE SURVEY WAS MADE WITH A TWC PERSON CREW USING TRIMBLE 5700 SERIES GEODETIC G.P.S. RECEIVERS OPERATED IN REAL TIME KINEWAITC MODE. CONTROL MEASURGENITS AND MONUMENTS ESTABLISHED FOR PARCEL I WERE VERIFIED BY REDUNDANT OBSERVATIONS. THE RIGHT—OF—WAY LINE OF STATE HIGHWAY NO. 37, FRONTING PARCEL 1 WAS DETERMINED AS NOTED ON SHEET 1 OF 2.
