

SURVEYOR'S CERTIFICATE & NARRATIVE:

I, G. DENNIS EDWARDS, AM A REGISTERED SURVEYOR OF THE STATE OF OREGON AND HAVE MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THIS

I DID NOT SURVEY PARCEL 2. I SURVEYED PARCEL ONE EXCEPT FOR THAT PORTION OF WESTLAND IRRIGATION DISTRICTS TRACT THE SOUTH LINE OF WHICH WAS THE CENTER LINE OF A CANAL AS IT EXISTED IN 1980. THAT CANAL HAS SINCE BEEN MOVED. I SCALED ITS LOCATION FROM O.D.O.T.'S R/W MAP # 9B-16-21.

THIS SURVEY WAS CONDUCTED WITH A TOPCON HIPER+ G.P.S. IN REAL TIME KINEMATIC AND THE BEARINGS WERE ROTATED TO MATCH MY 1994 SURVEY FOR O.D.O.T.

DESCRIPTION: THAT PORTION OF THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 5 AND THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 6, TOWNSHIP 4 NORTH, RANGE 28 EAST, WILLAMETTE MERIDIAN, UMATILLA COUNTY LYING SOUTH OF THE SOUTH RIGHT OF WAY LINE OF INTERSTATE HIGHWAY 82 AND SOUTH OF THE SOUTH LINE OF THOSE TRACTS OF LAND DEEDED TO WESTLAND IRRIGATION DISTRICT ON REEL 156, PAGE 5, UMATILLA COUNTY DEED RECORDS.
