




## SURVEYOR'S CERTIFICATE & NARRATIVE:

I HEREBY DEDICATE 60 FOOT WIDE STRIP OF LAND AND A 50 FOOT CUL—DE—SAC FOR A NONEXCLUSIVE PUBLIC ACCESS EASEMENT AS SHOWN ALONG THE SOUTH LINE OF PARCEL 3 AND THE EAST LINE OF PARCEL 2 AND AT THE N.E. CORNER OF PARCEL 1. SAID EASEMENT IS ALSO FOR UTILITIES AND PRIVATE IRRIGATION EASEMENTS WHERE SHOWN AND IS FOR THE USES OF ALL THREE PARCELS.

I ALSO DEDICATE A 20 FOOT PRIVATE IRRIGATION EASEMENT ALONG THE EAST SIDE OF PARCEL 1 FOR THE USE OF ALL THREE PARCELS.

I ALSO DEDICATE A 20 FOOT UTILITY EASEMENT ALONG THE NORTH LINE OF PARCEL 3 FOR EXISTING AND FUTURE LITHETIES
