

THE SURVEY WAS MADE WITH A TWO PERSON CREW USING TRIMBLE 5700 SERIES GEODETIC G.P.S. RECEIVERS OPERATED IN REAL TIME KINEMATIC MODE. CONTROL. MEASUREMENTS AND MONUMENTS ESTABLISHED FOR PARCEL 1 WERE VERIFIED BY REDUNDANT OBSERVATIONS.
