## **OWNER'S DECLARATION:**

WE, THE OWNERS OF THE ABOVE DESCRIBED LAND, HEREBY DECLARE THAT WE HAVE CAUSED THIS PLAT TO BE PREPARED. WE HEREBY DEDICATE A 60 FOOT WIDE NONEXCLUSIVE EASEMENT AND 50 FOOT CUL-DE-SAC AS SHOWN ALONG THE EAST LINE OF PARCEL 1 FOR INGRESS AND EGRESS, UTILITIES, AND FOR IRRIGATION PIPE LINES.

WE ALSO HEREBY DEDICATE A NONEXCLUSIVE IRRIGATION EASEMENT FOR THE INSTALLATION AND MAINTENANCE OF IRRIGATION PIPELINES THE WIDTH OF WHICH IS SHOWN (10' AND 20') AND RUNS ALONG THE SOUTHERLY LINE, THE EAST LINE AND ACROSS THE CENTER OF PARCEL 3.

WE ACKNOWLEDGE THE 15 FOOT WIDE ROAD STRIP WHICH RUNS ALONG THE EAST LINE OF THIS PROPERTY EVEN THOUGH SAID STRIP HAS NEVER BEEN USED AS A ROAD. WE ALSO ACKNOWLEDGE THAT EDWARDS SET MONUMENTS ON THE EAST SIDE OF SAID ROAD STRIP WHICH IS THE NORTH-SOUTH CENTERLINE OF SECTION 4. THE WEST LINE OF SAID ROAD STRIP LIES 15 FEET WEST OF SAID NORTH-SOUTH


