

I, CERTIFY THAT I HAVE CORRECTLY SHOWN AND MONUMENTED PARCEL 1 OF THIS PARTITION PLAT IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED, AND THE DIMATILA COUNTY DEVELOPMENT GORNANCE. PARCEL 1 IS SURVEYED AND MONUMENTED AS SHOWN ON SHEET 1 OF 2. PARCEL 2 IS UNSURVEYED, AND IS SHOWN GRAPHICALLY ON THE VIGHTY MAP ON SHEET 1 OF 2. AS ALLOWED UNDER CHAPTER 152.644(7) OF THE UMATILLA COUNTY DEVELOPMENT ORDINANCE.
