NEW INGRESS / EGRESS EASEMENT

Township 2 North, Range 31, E.W.M., Umatilla County, Oregon:

Section 3: Southwest Quarter.

Section 9: All that portion of the East Half lying Easterly of County Road No. 1109, Barnhart Road.

Section 10: Northwest Quarter and South Half.

Section 15: All that portion of the West Half of the Northeast Quarter lying Northerly of County Road No. 799, Rieth Road.

All that portion of the Northwest Quarter lying Northerly of County Road No. 799, Rieth Road.
