AFFIDAVIT OF CORRECTION



I, Jason M. Wells, Oregon Professional Land Surveyor No. 54657PLS, being duly sworn, depose and say that I am the surveyor who surveyed the property as depicted and filed as Umatilla County Partition Plat No. 2017-17.

The following corrections to said Partition Plat are necessary and are as follows:

A "preliminary" property line adjustment was made in 2005 by William R. Wells, PLS No. 1106, between Tax Lots 3200 (Lot 28 of Royal Ridge Subdivision Phase I), and Tax Lot 1600 (Lot 27 of Royal Ridge Subdivision Phase I), and a strip of property was deeded from Lot 28 to Lot 27. The deed is recorded as Instrument No. 2005-4850552, Umatilla County Deed Records, and is included in this Affidavit and marked Exhibit "A". However, Wells' records indicate that the property line adjustment survey was never recorded because the property line adjustment process was not totally completed. The City of Pendleton, who would have authorized the property line adjustment, has no record for a property line adjustment. A search at the Umatilla County Surveyors Office does not produce a recorded survey map. A survey map marked "preliminary" in the signature portion of William R. Wells' registration stamp was recovered in Pioneer Title Company, Pendleton, Oregon, File No. 76762. Also, a deed for a new 5' wide utility easement granted to the City of Pendleton, as depicted in Exhibit "B", included herein, was prepared and recorded as Instrument No. 2005-4830697. It is unclear who prepared and recorded either of the deeds.

Exhibit "B" is a copy of a portion of the unrecorded "preliminary" property line adjustment survey and depicts a strip of property to be removed from Lot 28 and attached to Lot 27. The deed recorded as Instrument No. 2005-4850552, deeds this strip of property (415 S.F.), from Lot 28 to Lot 27. My survey does not depict this and shows only the original line and dimensions to it, not the new line as shown in Exhibit "B". Because of this the acreage of Lot 28 is also in error and should read 1,113,720 S.F. or 25.57 acres.

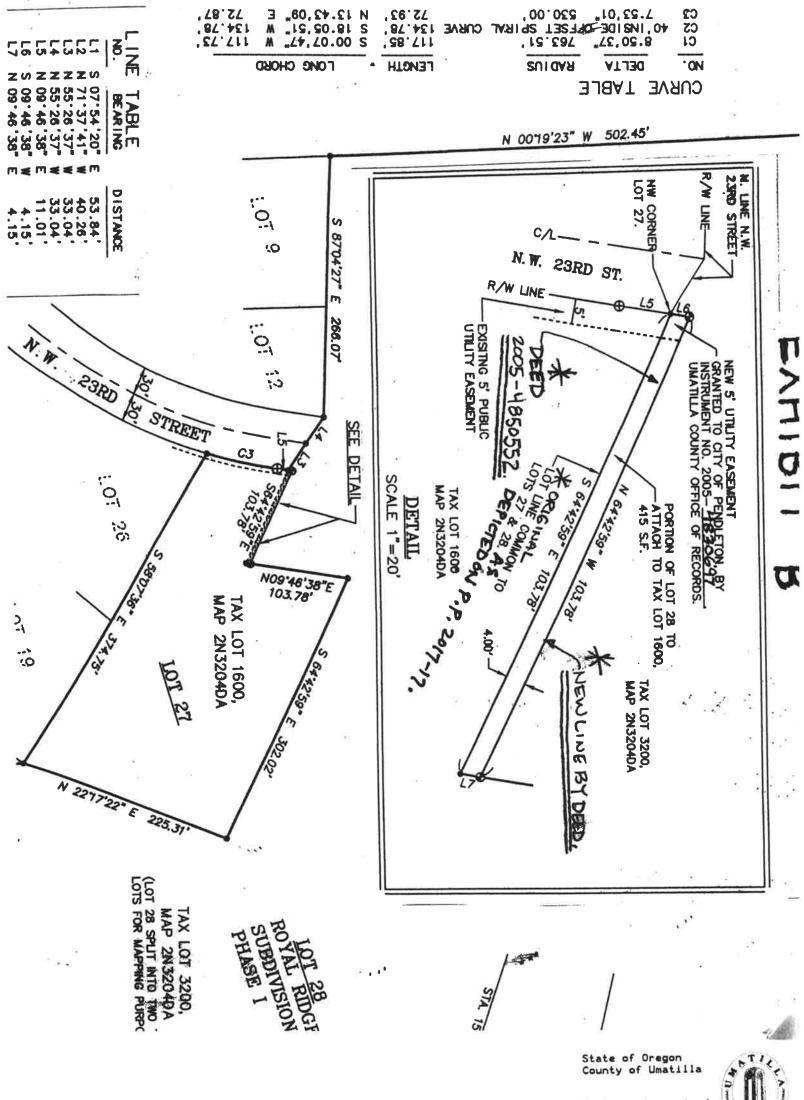
Lot 27, ROYAL RIDGE SUBDIVISION, PHASE I, an Addition to the City of Pendleton, Umatilla County, Oregon.
