SURVEYORS CERTIFICATE & NARRATIVE

I CERTIFY THAT I HAVE CORRECTLY SHOWN PARCELS 1 AND 2 OF THIS PARTITION PLAT IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED, AND THE CITY OF PENDLETON AND UMATILLA COUNTY DEVELOPMENT ORDINANCES. PARCEL 1 IS MONUMENTED AS SHOWN. THE NORTHERLY LINE OF. PARCEL 2 IS MONUMENTED AS SHOWN. THE SOUTHERLY LINE OF PARCEL 2, BEING PRIMARILY ON THE RIVER SIDE OF THE LEVEE IS NOT MONUMENTED, AS WAS ALLOWED BY THE UMATILLA COUNTY SURVEYOR.

THE BASIS OF CONTROL ARE THE RECORD SURVEYS IDENTIFIED ON SHEET 1 OF 2. THE BASIS OF BEARINGS FOR THIS PARTITION PARTITION SURVEY IS NORTH 88'05'53" EAST BETWEEN FOUND MONUMENTS AT THE INTERSECTION OF CENTERLINES OF NW DESPAIN AVENUE AND NW 5TH AND MAIN STREETS. THE RECORD COURSES IN THE LEGAL DESCRIPTION OF THE PARTITIONED LAND ARE WRITTEN ON TWO SEPARATE BEARING BASIS, 3 MINUTES AND 30 SECONDS OF ANGLE APART. GENERALLY BEARINGS SOUTH OF THE RIVER ARE BASED ON THE RESERVE ADDITION PLAT AND BEARINGS NORTH OF THE RIVER ARE BASED ON THE BEARING OF NW DESPAIN AVENUE BEING SOUTH 88'02'30" WEST AND NORTH 88'02'30" EAST. HARRIS SURVEY NO. Q-279-B SOUTH OF NW 5TH STREET WAS DETERMINED TO BE WRITTEN WITH REFERENCE TO THE NW DESPAIN AVENUE BEARING BASE.

VIRTUALLY ALL OF THE PARTITIONED PROPERTY IS SHOWN WITHIN THE "RIGHT-OF-WAY" SHOWN ON THE 1956 CORPS OF ENGINEERS LEVEE MAPS. I FIND NO RECORD THAT THE "RIGHT-OF-WAY" SHOWN ON THE CORPS OF ENGINEERS MAPS WAS EVER ACQUIRED BY THE CORPS OR THE CITY OF PENDLETON.

THIS PARTITION SURVEY WAS MADE BY A TWO PERSON CREW USING A LEICA TCR 3 SECOND TOTAL STATION. CONTROL MONUMENT TIES AND CORNER SET WERE VERIFIED BY REDUNDANT MEASUREMENTS.

REAL PROPERTY DESCRIPTION

A TRACT OF LAND SITUATED IN THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 10, TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M., UMATILLA COUNTY, OREGON, DESCRIBED AS FOLLOWS:
