SURVEYOR'S CERTIFICATE / NARRATIVE

THIS SURVEY FOR PARTITION WAS MADE TO PARTITION AN EXISTING HOUSE AND CERTAIN OUTBUILDINGS FROM A LARGER FARM TRACT.

I RECOVERED AND USED MONUMENTS DEPICTED IN THE VICINITY MAP FOR SURVEY CONTROL FOR THIS PARTITION. THE MONUMENTS USED WERE PREVIOUSLY ESTABLISHED IN SURVEY NO. M-108-8 AND 15-052-C. THE TOWNSHIP LINE DISTANCES IN 15-052-C WERE SCALED TO GROUND BY THE PUBLISHED SCALE FACTOR IN SAID SURVEY. THE RESULTING CALCULATED ANGLE POINTS ARE SHOWN. THE EAST LINE OF PARCEL 1 AND PARCEL 3 WAS ESTABLISHED ALONG LONG STANDING USE LINES. THESE USE LINES AND FENCES HAVE BEEN IN PLACE FOR OVER 100 YEARS PER THE OWNER. FENCE CORNERS WERE TIED AND HELD AT EACH END OF THE LINE AS NOTED HEREIN TO CALCULATE THE REMAINING AREA. THE REMAINING BOUNDARY OF PARCEL 1 IS UNSURVEYED AND CALCULATED FROM ORIGINAL SUBDIMISION BREAKDOWN NOTES. COLD SPRINGS ROAD, CO. RD. 850 (CO.RD. 563), WAS ESTABLISHED BY A BEST FIT OF THE TRAVELED WAY. THE SURVEY USED LEICA GEODÉTIC GPS RECEIVERS OPERATED IN REAL TIME ON THE OREGON COORDINATE REFERENCE FRAME AND A CONVENTIONAL LEICA TOTAL STATION. MONUMENTS TIED AND NEW MONUMENTS SET WERE VERIFIED BY REDUNDANT OBSERVATIONS. THE RESULTING WORK WAS THEN ROTATED TO THE CALCULATED LINE BETWEEN FOUND MONUMENTS 100 AND 101 PER SURVEY NO. 15-052-C. SAID SURVEY BASIS OF BEARINGS IS THE OREGON STATE PLANE COORDINATE SYSTEM.

I HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH LEGAL MONUMENTS, THE LANDS SHOWN ON THE THE ACCOMPANYING PLAT, IN ACCORDANCE WITH ORS CHAPTER 92, AND THE UMATILLA COUNTY DEVELOPMENT ORDINANCE. PARCEL 2 AND PARCEL 3 ARE MONUMENTED WITH REBAR MONUMENTS AS SHOWN ON THIS SHEET. PARCEL 1, BEING OVER 10 ACRES IN SIZE IS UNMONUMENTED EXCEPT FOR CERTAIN MONUMENTS FOUND FROM SURVEY NO.
