

## **SURVEYORS CERTIFICATE & NARRATIVE:**

I CERTIFY THAT I HAVE CORRECTLY SHOWN AND MARKED WITH LEGAL MONUMENTS PARCELS 1 AND 2 OF THIS PARTITION PLAT IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED, AND THE CITY OF ADAMS AND UMATILLA COUNTY DEVELOPMENT ORDINANCES. MONUMENTS FOUND AND ESTABLISHED ARE NOTED. THE SURVEY WAS MADE AT THE REQUEST OF KEITH LARSEN, CONTRACT PURCHASER TO DIVIDE THE PROPERTY INTO TWO PARCELS TO SEPARATE EXISITNG MOBILE HOMES AS SHOWN. BLOCK 4 & 5, ALONG WITH THE BOUNDING STREETS HAVE BEEN SURVEYED ON PREVIOUS SURVEYS. I HOLD SURVEY NO. 03-58-B AS THE BASIS OF BEARINGS FOR THIS SURVEY. AS STATED ON SAID SURVEY AND DEPICTED ON THE ORIGINAL PLAT OF HOLDMAN'S WEST ADDITION, AN ALLEY NEVER EXISTED BETWEEN BLOCKS 4 AND 5. IN NOVEMBER OF 1991 PER ORDINACE 170, RECORDED IN REEL 212, PAGE 1326, THE CITY OF ADAMS IN ERROR VACATED A 20 FOOT WIDE ALLEY BETWEEN BLOCKS 4 AND 5. ALL SUBSEQUENT DEEDS ARE IN ERROR GRANTING PORTIONS OF THE 20 FOOT WIDE ALLEY TO THE ADJOINING PROPERTIES. THE "ALLEY" PROPERTY WAS AND IS IN FACT THE SOUTHERLY 20 FEET OF BLOCK 5. THE ORIGINAL PLAT SHOWS AN ALLEY IN THE BLOCK EAST AND WEST OF BLOCKS 4 AND 5. THE ERROR WAS MOST LIKELY CAUSED BY AN ASSESSOR MAP SHOWING AN ALLEY AND THE ORIGINAL PLAT NOT BEING CONSULTED. THERE IS A SCRIVENER'S ERROR IN SURVEY 03-58-B SHOWING ALL EAST-WEST BEARINGS BEING NORTH 84'44'27" WEST WHEN IN FACT THEY SHOULD READ NORTH 88'44'27" WEST.

THE SURVEY WAS MADE WITH A ONE PERSON CREW USING A LEICA GS14 GPS RECEIVER OPERATED OVER THE ORGN NETWORK. MONUMENTS SET WERE VERIFIED BY SEPATRATE OBSERVATIONS.
