ENGLISH, OREGON PROFESSIONAL LAND SURVEYOR NUMBER 43406LS, BEING DULY SWORN, DEPOSE AND SAY THAT I HAVE SURVEYED AND MARKED WITH LEGAL MONUMENTS THE LANDS SHOWN ON THIS PARTITION AS SHOWN HEREIN. SAID PARTITION IS SITUATED IN THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 2 NORTH, RANGE 32, EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON. THE PURPOSE OF THIS PARTITION IS TO DIVIDE SAID TAX LOT 207 INTO 2 DISTINCT PARCELS.

I FURTHER CERTIFY AND SAY THAT I MADE THIS SURVEY AND PLAT BY ORDER OF AND UNDER THE DIRECTION OF THE OWNERS THEREOF, AND THAT ALL BOUNDARY CORNERS ARE MARKED WITH MONUMENTS AS INDICATED ON THE AMENDED MAP IN ACCORDANCE WITH THE PROVISIONS OF O.R.S. 92.050 AND 92.060.

THE INITIAL POINT IS A 5/8"X30" IRON REBAR WITH A YELLOW PLASTIC CAP MARKED "ORPLSII06" AND "WAPLSI7372", SET BY WELLS, AT THE SOUTHWEST CORNER OF TAX LOT NUMBER 300, DURING PARTITION PLAT 1998-55.

### SURVEYOR'S NARRATIVE:

THIS SURVEY WAS PERFORMED AT THE REQUEST OF LAURA MCMINN, OWNER, TO PERFORM A PARTITION PLAT AND SEPARATE THE 5.0 ACRE PARCEL INTO TWO PIECES, CURRENTLY KNOWN AS TAX LOT 207 OF ASSESSOR'S MAP 2N3234 (SEE R2 AND D5), LOCATED IN THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 2 NORTH, RANGE 32 EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON.

I WAS ABLE TO LOCATE SEVERAL OF THE PROPERTY CORNERS OF COUNTY SURVEY I-4I-B, BY STAEBLER (ONE OF WHICH LOOKS TO BE OBVIOUSLY DISPLACED), TWO CORNERS FROM 83-II-B, BY KRUMBEIN, AND THREE CORNERS SET IN PARTITION PLAT, BY WELLS. THE FASHION OF THE SURVEYS FOUND FOR THIS AREA ALL APPEAR TO HAVE BEEN IN THE STYLE OF A PARTITION AND DEVELOPMENT OF PARCELS. AS TO BE EXPECTED WITH TIME, FENCING OPERATIONS, GROUND MOVEMENT, ETC. SEVERAL OF THE CORNERS VARY SLIGHTLY FROM RECORD CALLS, ALTHOUGH MOST FALL EASILY WITHIN THE 0.10' AS REQUIRED BY O.R.S.

I HOLD THE NORTH LINE OF I-4I-B AS THE BASIS OF BEARING FOR THIS SURVEY AND I APPLY A COMBINED SCALE FACTOR OF 0.99986304 CALCULATED FROM LAT AND LONG USING NOAA NCAT SOFTWARE, FROM GROUND TO GRID. (I.E. I.00012843 GRID TO GROUND TO MY RTK GPS MEASUREMENTS). SURVEYOR'S NOTE: THE DEED FOR TAX LOT 207 WAS WRITTEN FROM SURVEY I-4I-B AND HAS AN ERROR IN THE DOCUMENT NO. 2016-6520439 ON THE INITIAL BEARING CALL FROM THE NORTHWEST CORNER OF SECTION 34, BEING SOUTH 89°51'20" EAST, AND IT SHOULD BE SOUTH 89°57'20" EAST TO MATCH THE SURVEY. ALL OTHER BEARINGS MATCH TO SAID SURVEY.

THIS SURVEY WAS PERFORMED USING A SOKKIA GSR 2700IS RTK GPS SYSTEM. STANDARD ERROR FOR THE RTK SYSTEM IS 10.0MM + I PPM X BASELINE MEASURED, IN MILLIMETERS.
I FIND NOTHING OUT OF THE ORDINARY ON THIS SURVEY.
