ENGLISH, OREGON PROFESSIONAL LAND SURVEYOR NUMBER 43406LS, BEING DULY SWORN, DEPOSE AND SAY THAT I HAVE SURVEYED AND MARKED WITH LEGAL MONUMENTS THE LANDS SHOWN ON THIS PARTITION AS SHOWN HEREIN. SAID PARTITION IS SITUATED IN THE NORTHWEST QUARTER OF SECTION 3. TOWNSHIP 3 NORTH, RANGE 33, EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON. THE PURPOSE OF THIS PARTITION IS TO SEPARATE THE OLD HOMESITE FROM THE ACTIVE FARM GROUND OF SAID TAX LOT 1100.

I FURTHER CERTIFY AND SAY THAT I MADE THIS SURVEY AND PLAT BY ORDER OF AND UNDER THE DIRECTION OF THE OWNERS THEREOF, AND THAT ALL BOUNDARY CORNERS ARE MARKED WITH MONUMENTS AS INDICATED ON THE AMENDED MAP IN ACCORDANCE WITH THE PROVISIONS OF O.R.S. 92.050 AND 92.060.

THE INITIAL POINT IS A 5/8"X30" IRON REBAR WITH A RED PLASTIC CAP MARKED "ORPLS43406LS" AND "WAPLS44338", SET AT THE NORTHEAST CORNER OF THE PROPOSED PARCEL 2 OF THIS PLAT, DURING THE PERFORMANCE OF THIS PARTITION.

SURVEYOR'S NARRATIVE:

THIS SURVEY WAS PERFORMED AT THE REQUEST OF BOBBY COREY, OWNERS REPRESENTATIVE, TO PERFORM A PARTITION PLAT AND SEPARATE THE HOMESITE ON THE PROPERTY CURRENTLY KNOWN AS TAX LOT IIOO OF ASSESSOR'S MAP 3N33, ALSO BEING THE NORTHWEST QUARTER OF SECTION 3, TOWNSHIP 3 NORTH, RANGE 33 EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON.

I PERFORMED COUNTY SURVEY 12-094-C WHICH WAS THE COUNTY SURVEY TO MONUMENT AND RECORD FOUND MONUMENTS IN TOWNSHIP 3 NORTH, RANGE 33 EAST, AND HOLD THE LINE BETWEEN THE NORTH QUARTER CORNER AND THE NORTHWEST CORNER OF SECTION 3 AS THE BASIS OF BEARING FOR THIS PARTITION. AS PER THE RECORD FOR SAID SURVEY I HOLD GRID BEARINGS.

I APPLY A COMBINED SCALE FACTOR OF 0.99987096 CALCULATED FROM LAT AND LONG USING NOAA NCAT SOFTWARE, FROM GROUND TO GRID. I SHOW BOTH GRID AND GROUND DISTANCES, AND AREAS ON THIS DRAWING TO CORRELATE TO 12-094-C.

THIS SURVEY WAS PERFORMED USING A SOKKIA GSR 2700IS RTK GPS SYSTEM. STANDARD ERROR FOR THE RTK SYSTEM IS 10.0MM + I PPM X BASELINE MEASURED, IN MILLIMETERS. I FIND NOTHING OUT OF THE ORDINARY ON THIS SURVEY.
