

NARRATIVE

TOWNSHIP 1 SOUTH

This partition was done at the request of Jay Wheelhouse, owner of the land within. Mr. Wheelhouse wanted to partition as shown. This partition is UNSURVEYED. Bearings and distances of unsurveyed lines shown hereon are based on record distances as per stated title report, Partition Plat 2008–17 and Survey Number 97–223–B. I place the dividing line at the direction of Mr. Wheelhouse. The Northern terminus of the dividing line between the parcels fell on a line described by metes and bounds for which I could find no filed survey. There are unrecorded 1" OD pipes that fall in several of the fence corners that are relatively harmonious with the calls of the deed. The landowner has known this line to be previously surveyed with the intent to have followed the existing fenceline. I find that the angle point in the fence, where this partition line terminates to be harmonious with the found pipes and fence corners. Because of the harmony with records, landowner testimony and the apparent age of the fence, I accept the existing fence corner as representing the angle point between lines 51 and 52. The beginning point on the South line of the dividing line was placed on line between monuments set by Survey Number 97–223–B, which I find to be harmonious with record. Both of these are detailed on Page 3 of this partition. With exception of the terminus of these lines, no attempts were further made to resolve exterior boundaries. I find no unusual conditions with this partition.




