## SURVEYOR'S CERTIFICATE & NARRATIVE:

THIS LAND PARTITION EXHIBIT AND PARTIAL SURVEY WAS MADE AT THE REQUEST OF THE WEST TRUSTS AND MR. SAMUEL J. "COKE" RAMOS. THE PURPOSE OF THE WORK IS TO PARTITION REVISED TAX LOT 10700, ASSESSOR MAP NO. 3N 29 INTO TWO PARCELS. REVISED TAX LOT 10700 WAS RECENTLY CREATED BY UMATILLA COUNTY PROPERTY LINE ADJUSTMENT #LD-3N-216-19.

THE OVERALL BOUNDARY IS UNMONUMENTED EXCEPT FOR THOSE SECTION AND ONE-QUARTER SECTION CORNERS RECOVERED OR REESTABLISHED AND MONUMENTED ON SURVEY NO. 92-065-C AND 11-038-C. I USED REPORTED DIMENSIONS FROM SURVEY NO. 11-038-C TO COMPUTED APPROXIMATE SECTION BREAKDOWN DIMENSIONS SHOWN. THE DIVISION LINE BETWEEN NEW PARCELS 1 AND 2 IS SURVEYED AS SHOWN ON SHEET 1 OF 2. THE TWO NEW EASEMENTS WERE SURVEYED BUT WERE NOT MONUMENTED.

THE SURVEY WAS MADE WITH TRIMBLE GEODETIC GPS RECEIVERS BY REAL TIME KINEMATIC METHODS. CONTROLLING CORNERS AND NEW MONUMENTS SET WERE VERIFIED BY REDUNDANT OBSERVATIONS.

I CERTIFY THAT I HAVE CORRECTLY SHOWN, SURVEYED AND MONUMENTED PARCELS 1 AND 2 OF THIS PARTITION PLAT IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED. I HEREBY DESIGNATE THE NORTHWEST CORNER OF SECTION 36, A 2 1/2 INCH BRASS CAP ON 1 1/4 INCH GALVANIZED IRON PIPE AS THE "INITIAL POINT" FOR THIS PARTITION.

REAL PROPERTY DESCRIPTION:

THE EAST HALF OF THE NORTHWEST QUARTER AND ALL THAT PORTION OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER LYING NORTH AND EAST OF THE CENTER OF THE CHANNEL OF THE UMATILLA RIVER AS IT WAS LOCATED ON JANUARY 2ND, 1906 IN SECTION 36, TOWNSHIP 3 NORTH RANGE 29, EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON:

EXCEPTING THEREFROM THAT PORTION LYING WITHIN COUNTY ROAD NO. 1300 AND THE RAILROAD RIGHT-OF-WAY; AND TOGETHER WITH ALL THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES THEREUNTO BELONGING OR IN ANYWISE APPERTAINING, INCLUDING WITHOUT LIMIT, ALL WATER AND WATER RIGHTS, DITCHES AND DITCH RIGHTS APPURTENANT THERETO, OR USED OR HELD FOR USE IN CONNECTION THEREWITH, AND HOWEVER EVIDENCED OR MANIFESTED.

THAT PORTION OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER WHICH LIES SOUTHERLY AND WESTERLY OF THE CHANNEL OF THE UMATILLA RIVER AS THE SAME EXISTED ON JANUARY 2, 1906.

## OWNER'S DECLARATION

SAMUEL J. RAMOS, OWNER, DO HEREBY ACKNOWLEDGE THIS PARTITION PLAT WAS PREPARED WITH MY KNOWLEDGE AND CONSENT IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED AND APPLICABLE PORTIONS OF THE UMATILLA COUNTY DEVELOPMENT ORDINANCE.

I HEREBY DESIGNATE THE 35.00 FOOT WIDE EASEMENT OVER AND ACROSS THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 36 AS A NEW 35.00 FOOT WIDE PRIVATE EASEMENT FOR INGRESS—EGRESS AND IRRIGATION DITCH OPERATION AND MAINTENANCE. THIS EASEMENT IS OVER AND ACROSS NEW PARCEL 1 AND IS SUBJECT TO THE RIGHT—OF—WAYS OF THE FURNISH DITCH, COUNTY ROAD NO. 1300 AND THE OREGON WASHINGTON RAILROAD AND NAVIGATION COMPANY. THIS EASEMENT IS APPURTENANT TO NEW PARCEL 2. THIS EASEMENT IS IDENTIFIED AS EASEMENT "A" AND IS DEPICTED ON SHEET 1 OF 2 ON DETAIL A. CHANGES IN THE METHOD OF IRRIGATION MAY OCCUR IN THE FUTURE. IN THE EVENT THE EXISTING DITCH IS NO LONGER REQUIRED TO DELIVER IRRIGATION WATER TO NEW PARCEL 2, THIS PRIVATE EASEMENT MAY BE TERMINATED BY RECORDING A TERMINATION OF USE DOCUMENT, SIGNED AND ACKNOWLEDGED BY THE OWNERS OF NEW PARCELS 1 AND 2, IN THE OFFICE OF UMATILLA COUNTY RECORDS.
