

SURVEYOR'S CERTIFICATE

I, Stephen K. Haddock, a Registered Professional Surveyor in the State of Oregon, do hereby certify that I have correctly surveyed and marked with legal monuments the lands partitioned hereon in accordance with ORS Chapter 92 as revised and that the Initial Point is the southwest corner of Parcel 2 as shown hereon and is marked with a 5/8" iron repar with an orange plastic cap stamped WTS and 56295LS set under Umatilla County survey 18-060-C. The lands partitioned by this plat are described as follows:

LEGAL DESCRIPTION

Township 4 North, Range 29, E.W.M., Umatilla County, State of Oregon, Section 5: The Southwest Quarter of the Northeast Quarter of the Northeast Quarter.

Excepting therefrom the North 2 acres thereof deeded to Robert M. Journot. et. ux, by deed recorded in Book 274, Page 64, Deed Records. Also excepting therefrom that portion of the Northeast Quarter described as beginning at a point on the east line of the Southwest Quarter of the Northeast Quarter of the Northeast Quarter of said Section 5 which lies South 1°00'43" East, a distance of 132 feet (8 rods) from the Northeast corner of said Southwest Quarter and running; thence continuing South 1 *00 '43" East along said East line a distance of 60.48 feet; thence South 88°24'39" West along a fence line as it existed on June 20, 1979, a distance of 647.31 feet, to a point on the east line of Banks Road (total right of way width of 30 feet); thence North 0°55'35" West along said East line of Banks Road, a distance of 67.47 feet to a point which lies 132 feet South of the North line of Southwest Quarter of the Northeast Quarter of the Northeast Quarter of said Section 5 when measured at right angles; thence North 89°01'45" East parallel with said North line, a distance of 647.18 feet to the point of beginning.

Also excepting therefrom lands conveved to Grady Banks by deed recorded in Microfilm R-146, Page 345, Office of Umatilla County Records, being that portion of the Northeast Quarter of said Section 5 described as Beginning at the Northeast corner of said Banks Tract, said point lies 192.48 feet South of the Northeast corner of the Southwest Quarter of Northeast Quarter of the Northeast Quarter of said Section 5 and running; thence West along the North line of said Banks Tract, a distance of 662.31 feet to a point on the West line of said Southwest Quarter: thence South along said West line, a distance of 134.50 feet; thence East parallel with the North line of said Banks Tract, a distance of 662.51 feet to a point on the East line of said Banks Tract; thence North along said East line, a distance of 134.50 feet to the point of beginning. Excepting therefrom the West 15 feet lying in Banks Road right of way.

Said tract contains 6.10 Acres, more or less.

Subject To: reservation of coal and iron rights, including the terms and provisions thereof reserved in deed by Northern Pacific Railway Co. Book 36 Page 133.

Subject To: Easement, including the terms and provisions thereof, reserved in deed by Maxwell Land and Irrigation Company recorded February 7, 1911 in Book 75, Page 15 deed records. (Banks Road right of way.)

Subject To: Easement, including the terms and provisions thereof, Grantee Umatilla Electric Cooperative Association recorded April 14, 1938 in Book 120, Page 514, deed records.

Subject To: Water Well Easement and agreement, including the terms and provisions thereof, disclosed in deed recorded March 8, 1989 in Reel 177. Page 410. deed records. (Provides water to the lands of Parry Reid.)

Subject To: Easement for ingress, egress and road purposes, including the terms and provisions thereof, disclosed in deed recorded February 13th. 1996 in Reel 284, Page 1539, deed records.

NARRATIVE OF SURVEY

This partition was prepared at the request of Mr. Terry Journot. The purpose of the survey was to partition the lands described in deed 2015-6350741, Umatilla County Deed Records.

As stated in survey 18-060-C, this section was first subdivided in 1910 by Geary Kimbrell in a survey for the Maxwell Land and Irrigation Company. This section was again subdivided under survey N-12-B by Ivan Driver in 1975. In June of 1976 (see survey L-3-Ax) Denny Edwards held a bearing base and a position for the C1/4 established by him in an unrecorded 1975 survey. In survey N-12-B, Mr. Driver monumented the NE corner of this section. Then in 1978 (survey P-72-A) Denny Edwards established his own monument for the NE corner of the section approximately 10' east of Driver's monument. In his January 1979 survey for Tindol and Banks (Q-114-B) Mr. Edwards marked the east and west lines of what is now the Journot property stating that his survey overlapped some surveys on the east and left a gap in Banks Lane. He also stated that the purpose of that survey was to "solve the problem of erroneous surveys done in this section". Mr. Edwards did not identify those surveys but chose to "leave them alone" because changing them would be "a tremendous task involving fence lines and deeds, etc...

The legal description for the Journot tract calls for the SW1/4 of the NE1/4 of the NE1/4. Due to Mr. Edwards establishment of a second NE section corner and a second subdivision of section, I have relied on the principle in Dykes -v- Arnold to resolve the discrepancy created by this situation. For this survey I have held the west line of the Journot tract to be the 1/16th line identified and monumented by Driver in survey N-12-B (as did Edwards in surveys M-97-A and P-121-A). I have held the east line to be the line identified and monumented by Edwards in surveys P-66-Ax, P-117-Ax, Q-114-B, and others. The north and south lines of the Journot tract were determined from the deed calls and Edwards surveys Q-114-B and 82-14-Ax. The aliquot part lines identified by these separate surveys have controlled the occupation of the properties in this aliquot part for more than 40 years and I therefore hold them as the true boundaries of this property.

This survey was performed with a Trimble R7/R8 RTK GPS system

BANKS LANE RIGHT OF WAY

The right of way of Banks Lane has been improperly represented by the county assessor's map, partition plats 1994-33, 1995-14, 1998-28, 2009-03, and 2019-12 as well as several record surveys. This right of way was established by the Maxwell Land and Irrigation Company between December of 1909 and March of 1915 by reservation of the easement in the following deeds recorded in the Umatilla County Deed Records: Book 67, Page 222; Book 67, Page 224; Book 71, Page 579; Book 75, Page 13; Book 75, Page 15, Book 75, Page 16; Book 75, Page 17; Book 75, Page 135; and Book 92, Page 65. The right of way created by these documents is 30 feet wide lying 15 feet on each side of the north-south centerline of the NE1/4 of Section 5. One additional road easement was granted along the west 15 feet of the lands being partitioned on this plat by the deed recorded in Microfilm Reel 284, Page 1539.
