## SURVEYOR'S CERTIFICATE & NARRATIVE

THIS LAND PARTITION SURVEY WAS MADE AT THE REQUEST OF ATTORNEY GEORGE ANDERSON. ONE OF THE THREE REFEREES APPOINTED BY THE UMATILLA COUNTY CIRCUIT COURT IN THE CASE OF CANNON ET AL. VS CANNON ET AL., UMATILLA COUNTY CIRCUIT COURT NO. 18CV27534. THE OTHER REFEREES ARE GRANELLA THOMPSON, AREA FARMER, AND BAKER CITY ATTORNEY ANDREW MARTIN. GRANELLA THOMPSON AND I MET SEPARATELY WITH ROBERT CANNON, (REPRESENTING HIMSELF AND SISTER SHARON CANNON BERGMAN), AND WITH DAVID CANNON TO DISCUSS THE DIVISION LINE BETWEEN PARCELS 1 AND 2 AND SET TEMPORARY STAKES ALONG THE PARCEL DIVISION LINE. THE TEMPORARY STAKES WERE SET WITH REFERENCE TO THE DIVISION LINE DEPICTED ON "EXHIBIT 1 MAP" CONTAINED IN THE "REFEREES' REPORT RECOMMENDING PARTITION". THE TEMPORARY STAKES WERE ADJUSTED AS DIRECTED BY REFEREE GRANELLA THOMPSON. I THEN SET REBAR MONUMENTS AT THE LOCATIONS OF THE ADJUSTED STAKES, ALONG WITH A STEEL FENCE POST BESIDE EACH REBAR MONUMENT. I SET STEEL FENCE POSTS, ON THE PARCEL DIVISION LINE, WHEN THE REBAR MONUMENTS WERE NOT INTER-VISIBLE.

THE AREA TO BE PARTITIONED IS THE EAST HALF OF SECTION 32 AND WEST HALF OF SECTION 33, COMBINED, IN TOWNSHIP 5 NORTH, RANGE 34 EAST, W.M. THE LAND AREA CONTAINED IN THE PARTITION IS SIGNIFICANTLY MORE THAN THE LAND AREA REPORTED IN THE 1865 GOVERNMENT SURVEY BY W. ODELL, ET AL., THE RESULT OF THE ORIGINAL SURVEYOR'S USING SHORTCUTS AND IMPROPER METHODS. I WAS ABLE TO EVALUATE, RE-ESTABLISH AND MONUMENT THE SOUTH 1/4 CORNER OF SECTION 33 ONLY AND THE SECTION CORNER COMMON TO SECTIONS 28, 29, 32 AND 33. I ALSO VISITED THE NORTH 1/4 CORNER OF SECTION 33 AND RE-ESTABLISHED IT'S POSITION AT THE INTERSECTION OF FIELD LINES AND BERMS EXTENDING SOUTH AND WEST. I DID NOT REMONUMENT THIS CORNER. VISITED THE LOCATION OF THE NORTH 1/4 CORNER OF SECTION 32 AND THE SECTION CORNER COMMON TO SECTIONS 29, 30, 31 AND 32 TIED THE APPROXIMATE CORNER LOCATIONS AT THE INTERSECTION CENTERLINE OF THOMPKINS ROAD AND FIELD LINES EXTENDING SOUTH AND NORTH-SEE SHEET 1 OF THIS PARTITION PLAT. I MAPPED THE APPROXIMATE LOCATION OF SECTION CORNER COMMON TO SECTIONS 32 AND 33 ONLY AND THE SOUTH 1/4 CORNER OF SECTION 32 ONLY, WITH REFERENCE TO GOOGLE MAP IMAGES, 1956 AERIAL PHOTOGRAPHS AND 7 1/2 MINUTE QUADRANGLE MAPS LAST UPDATED IN 1966. THE NORTH-SOUTH CENTERLINE OF SECTION 32, WHICH WOULD NORMALLY BE A STRAIGHT LINE BETWEEN SOUTH AND NORTH 1/4 CORNERS SHOWS A DISTINCT ANGLE POINT ABOUT 2640 FEET SOUTH OF THOMPKINS ROAD, SUGGESTING THE NORTH HALF MILE MAY HAVE BEEN "STUBBED IN" BY A SURVEYOR AFTER THE 1865 ORIGINAL SURVEY. I FIND NO RECORD OF ANY SURVEY OF THIS LINE IN COUNTY SURVEY RECORDS, BUT NOTE THE OLD 1956 AERIAL PHOTOS SHOW THE FIELD LINES AS THEY CURRENTLY EXIST.

THIS PARTITION SURVEY WAS MADE A LEICA GEODETIC GPS RECEIVER CONNECTED TO THE OREGON REAL TIME NETWORK. MEASUREMENTS WERE GATHERED ON THE OREGON STATE PLANE COORDINATE SYSTEM AND CONVERTED TO TRUE BEARINGS (AS INDICATED IN "BASIS OF BEARINGS" STATEMENT). MEASURED DISTANCES REPORTED ARE GROUND DISTANCES. CONTROL CORNER TIES AND CORNER MONUMENTS SET WERE VERIFIED BY REDUNDANT GPS

1 CERTIFY THAT I HAVE CORRECTLY SURVEYED, MONUMENTED AND MAPPED PARCELS 1 AND 2 IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED, AND APPLICABLE PORTIONS OF THE UMATILLA COUNTY DEVELOPMENT ORDINANCES. THE DIVISION LINE BETWEEN PARCELS 1 AND 2 IS MONUMENTED AS DEPICTED AND NOTED ON SHEET 1 OF 2. I DESIGNATE THE SOUTH 1/4 CORNER OF SECTION 33 ONLY, AS THE INITIAL POINT FOR THIS PARTITION SURVEY.
