

SURVEYOR'S CERTIFICATE

I, Stephen K. Haddock, a Registered Professional Surveyor in the State of Oregon, do hereby certify that I have correctly surveyed and marked with legal monuments Parcels 1 and 2 as shown hereon. I do also state that the initial point is monumented with a 5/8"x30" Iron Rebar with an orange plastic cap stamped WTS and 56295LS.

LEGAL DESCRIPTION

That tract of land located in the Southwest Quarter of the Southeast Quarter of Section 8, Township 1 South, Range 32 East, W.M., City of Pilot Rock, Umatilla County, Oregon, being all that part of those lands conveyed to James D. Hatley, Evelyn E. Hatley, and Jerry A. Hatley by the deeds recorded October 9, 2008 in Microfilm Reel 543, Pages 220 and 221, Deed Records of Umatilla County, Oregon, together with that part of vacated County Road 908A more particularly described under the heading of Parcel 2 in County Vacation Order RD2009-40 as said order was recorded on September 8th, 2009, in Microfilm Reel 556, Page 215 Deed Records of Umatilla County, Oregon, said tract being that part of the above referenced lands lying north of the northerly right of way line of County Road 1388 (Stock Drive Road) as said road was legalized under Order No. RD2014-26 recorded on December 3rd, 2014 in Microfilm Reel 623, Page 641, Deed Records of Umatilla County, Oregon, said tract being more particularly described as follows:

Commencing at the Southeast corner of the Southwest Quarter of the Southeast Quarter of Section 8, T1S, R32E.W.M., thence along the East line of said Southwest Quarter of the Southeast Quarter, North 0°22'03" East a distance of 433.49 feet to a point on the north line of County Road No. 1388 as said road was legalized by County Order RD2014-26, said order being recorded in Microfilm Reel 623, Page 641, Deed Records of Umatilla County, Oregon, said point also being the True Point of Beginning of this description; thence continuing along said East line. North 0°22'03" East a distance of 277.41 feet to the Northeast corner of that tract of land described in Exhibit A, Parcel 1 of the deed recorded in Microfilm Reel 543, Page 220, Umatilla County Deed Records; thence South 62°15'43" West a distance of 726.76 feet; thence South 60°35'37" West a distance of 81.23 feet to a point on the north line of said legalized County Road 1388; thence along said North line by the follwing courses and distances: 342.62 feet along the arc of a curve to the right having a radius of 306.72 feet and a central angle of 64°00'13", the long chord of which bears South 89°06'43" East a distance of 325.09 feet; thence 334.97 feet along the arc of a curve to the left having a radius of 250.54 feet and a central angle of 76°36'23", the long chord of which bears North 84°39'37" East a distance of 310.57 feet; thence North 46 °23'59" East a distance of 77.79 feet; thence North 42°56'51" East a distance of 31.73 feet to the True Point of Beginning. THE NEW PUBLIC UTILITY EASEMENT DEDICATED BY THIS PARTITION PLAT SHALL BE 10 FEET WIDE. THE PUE SHALL ABUT UPON AND LIE NORTHERLY OF THE SOUTH LINE OF BOTH PARCELS. THE PUE SHALL EXTEND THE ENTIRE WIDTH OF PARCEL 2 AND ACROSS THE EASTERLY 5 FEET OF PARCEL 1. UTILITIES SHALL HAVE THE RIGHT TO INSTALL, MAINTAIN AND OPERATE THETE FOULTBMENT AND ALL OTHER PELATED.

AND OPERATE THEIR EQUIPMENT AND ALL OTHER RELATED FACILITIES ABOVE AND BELOW GROUND WITHIN THE PUE AS MAY BE NECESSARY OR DESIREABLE IN PROVIDING UTILITY SERVICES WITHIN AND WITHOUT THE PARCELS IDENTIFIED HEREIN, INCLUDING THE RIGHT OF ACCESS TO SUCH FACILITIES AND THE RIGHT TO REQUIRE REMOVAL OF ANY OBSTRUCTIONS INCLUDING STRUCTURES, TREES, AND VEGETATION THAT MAY BE PLACED WITHIN THE PUE. THE UTILITY MAY REQUIRE THE PARCEL OWNER TO REMOVE ALL OBSTRUCTIONS AT THE OWNER'S EXPENSE. AT NO TIME MAY ANY PERMANENT STRUCTURES BE PLACED WITHIN THE PUE OR ANY OTHER OBSTRUCTION WHICH INTERFERES WITH THE USE OF THE PUE WITHOUT THE PRIOR WRITTEN APPROVAL OF THE UTILITIES WITH FACILITIES IN THE PUE.
