





NARRATTVF

This plat was prepared at the request of Mr. Jake Madison. The purpose of the plat is to partition the two farm parcels from the land described and shown hereon.

This partition is the culmination of a series of boundary This partition is the culmination of a series of boundary changes incidental to the continued operation of the farm. Those changes can be traced through surveys R9 to R13 listed in the legend. One additional boundary adjustment in the NE1/4 of the NE1/4 of Section 35 was processed under ORS92.060(8) and consequently has no record of survey and no monuments were set. Due to that situation, Parcel 2 of this partition remains unsurveyed. The dimensions of the exterior boundary of this partition are both measured and record based on the surveys cited above. The GPS control point for this series of surveys has remained stable and in good condition so that all of the survey control ties were made and monuments set from the same survey control ties were made and monuments set from the same point over the life of the project.

This partition was performed using a Trimble RBS RTK GPS base/rover pair.
