SURVEYOR'S CERTIFICATE & NARRATIVE

THIS LAND PARTITION PARTITION CREATES A 7.37 ACRE PARCEL OF LAND CONTAINING A HOUSE, BARN AND SEVERAL OLD FARM OUTBUILDINGS. THE 7.37 ACRE PARCEL 1 IS MONUMENTED AS SHOWN ON SHEET 1 OF 2. THE REMAINDER PARCEL 2 IS UNSURVEYED EXCEPT FOR PARTS OF THE SOUTH BOUNDARY DEPICTED ON THIS LAND PARTITION AND ON RECORD PARTITION PLAT NO. 2021-35.

THE SOUTHEAST CORNER OF SECTION 29 WAS RE-ESTABLISHED AND RE-MONUMENTED ON PARTITION PLAT NO. 2021-35. THE POSITION OF THE NORTHEAST CORNER OF SECTION 29 WAS DETERMINED AND MONUMENTED WITH A STONE IN A 1961 SURVEY BY WAYNE HARRIS, SURVEY NO. Q-783-C. THE STONE WAS REMONUMENTED WITH AN ALUMINUM PIPE MONUMENT IN 1991 ON SURVEY NO. 91-18-B. THE MONUMENT FOR THE NORTHEAST CORNER OF SECTION 29 IS APPROXIMATELY 50 FEET WEST OF THE CENTERLINE OF GERKING FLAT ROAD.

THE ORIGINAL 1879 ROAD NOTES, (ROAD #24A), FOR GERKING FLAT ROAD INDICATE THE OLD ROAD CENTERLINE WAS "ALONG THE SECTION LINE" THROUGH THE EAST 1/4 CORNER AND NORTHEAST CORNERS OF SECTION 29. A COUNTY ROAD DEPARTMENT MAP, DATED AUGUST 30, 1930, SHOWS THE ROAD CENTERLINE AT THE SECTION LINE AT THE EAST 1/4 CORNER AND NORTHEAST CORNER OF SECTION 29.

FOR THIS PARTITION SURVEY, I COMPUTED THE EAST 1/4 CORNER LOCATION AT THE INTERSECTION OF THE PHYSICAL CENTERLINE OF THE COUNTY ROAD WITH AN EXISTING FENCE AND FIELD LINE PROJECTION FROM THE WEST. I LAID OUT THE EAST LINE OF PARCEL 1 ON THE WEST RIGHT-OF-WAY LINE OF GERKING FLAT ROAD, 25 FEET FROM THE EXISTING PHYSICAL ROAD CENTERLINE. THE NORTH LINE OF PARCEL 1 IS NOT DIRECTLY MONUMENTED BUT IS ALONG THE NORTH LINE OF THE SOUTH HALF OF SECTION 29. THE SOUTHERLY AND WESTERLY LINE OF PARCEL 1 ARE LAID OUT AS DEPICTED ON SHEET 1 OF 2. AND ARE GENERALLY ALONG FARMED FIELD LINES.

THE IRREGULAR SECTION LINES IN SECTION 29 AND IN THIS TOWNSHIP ARE THE RESULT OF 1865 GOVERNMENT SURVEYOR W. ODELL, ET AL., USING SHORTCUTS AND IMPROPER METHODS IN SUBDIVIDING THE TOWNSHIP.

I CERTIFY THAT I HAVE CORRECTLY SURVEYED, MONUMENTED AND MAPPED PARCELS 1 AND 2 IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED, AND APPLICABLE PORTIONS OF THE UMATILLA COUNTY DEVELOPMENT ORDINANCES. PARCEL 1 IS MONUMENTED AS DEPICTED ON SHEET 1 OF 2. PARCEL 2 IS UNSURVEYED.
