This plat was prepared at the request of Mr. Steve Draper on behalf of the City of Pilot Rock, Oregon. The purpose of the plat is to partition Parcel 1 of Partition Plat 2019-26 into two new parcels as shown hereon.

The exterior boundary of this partition was surveyed and monuments set by myself under the several partitions as shown on this plat. The monuments for the new line between parcels 1 and 2 of this plat were established on line between the existing monuments to each side using the original control. The positions of the existing monuments and original control points were first confirmed as undisturbed and in good condition prior to setting the monuments for this partition.
