### SURVEYOR'S CERTIFICATE AND NARRATIVE:

I CERTIFY THAT I HAVE CORRECTLY SHOWN AND MONUMENTED PARCELS 1, 2 AND 3 OF THIS PARTITION PLAT IN ACCORDANCE WITH ORS CHAPTER 92, AS REVISED AND APPLICABLE PORTIONS OF THE UMATILLA COUNTY DEVELOPMENT CODE.

THE OVERALL BOUNDARY OF PARTITION PLAT NO. 2008-28, WAS DETERMINED ON THAT PARTITION PLAT BY MYSELF. THE PRESENT PARTITION PLAT IS MADE UP OF PARCEL 2 OF PARTITION PLAT NO. 2008-28 AND LOT 1, BLOCK 2, OF THE GREEN MEADOWS SUBDIVISION. I SEARCHED FOR ORIGINAL MONUMENTATION OF SAID LOT 1, BLOCK 2, BUT DID NOT RECOVER ANY ORIGINAL MONUMENTS ON IT'S BOUNDARY. IT'S BELIEVED THE ORIGINAL MONUMENTS WERE REMOVED BY BURIED WATER LINE CONSTRUCTION AFTER THE ORIGINAL PLAT WAS RECORDED IN 1960. I DETERMINED AND MONUMENTED THE BOUNDARY OF LOT 1, BLOCK 2 AS SHOWN. LOT 1, BLOCK 2 OF GREEN MEADOWS WAS LANDLOCKED. THE 30 FOOT WIDE INGRESS-EGRESS/UTILITY EASEMENT RECORDED AS INST. NO. 2023-0002216 WAS RECORDED TO PROVIDE ACCESS TO LANDLOCKED LOT 1, BLOCK 2 IN EXCHANGE FOR INCLUDING A PORTION OF SAID LOT 1, BLOCK 2, WITH NEW PARCEL 1, TO MAKE THE ACREAGE FOR NEW PARCEL 1 2.00 ACRES. GREEN MEADOWS WATER COMPANY WILL RETAIN NEW PARCEL 3 ALONG WITH AN INGRESS-EGRESS AND UTILITY EASEMENT OVER THE PORTION OF SAID LOT 1, BLOCK 2, INCLUDED IN NEW PARCEL 1. AFTER RECORDING THIS PARTITION PLAT TO CREATE THE NEW PARCELS, AN EXCHANGE DEED WILL BE NECESSARY TO CONVEY AND RELEASE INTERESTS IN FORMER LOT 1, BLOCK 2, GREEN MEADOWS.

ORIGINALLY, THIS REPLAT WAS SET UP AS A SUBDIVISION REPLAT, (LAND DIVISION, TYPE III), BUT IN NOVEMBER OF 2022, COUNTY PLANNING DECIDED TO PROCESS AND APPROVE THE LAND DIVISION AS A TYPE II.

THIS SURVEY WAS MADE WITH A GEODETIC GPS RECEIVER CONNECTED TO THE OREGON REAL TIME NETWORK AND WITH A ROBOT TOTAL STATION WHERE GPS SIGNAL WAS BLOCKED BY VEGETATION. CONTROLLING MONUMENTS AND NEW MONUMENTS SET WERE VERIFIED BY REDUNDANT MEASUREMENTS.
