SURVEYOR'S CERTIFICATE

I, Stephen K. Haddock, a Registered Professional Land Surveyor in the State of Oregon, do hereby certify that I have correctly surveyed and marked with legal monuments the lands described below. The Initial Point of this Replat is the same point as the Initial Point of OVERLOOK TERRACE REPLAT, PHASE ONE and is monumented with a 2 1/2" brass cap on a stainless steel pipe set in concrete 8 inches below the surface of the ground.

LEGAL DESCRIPTION

A tract of land located in the Southwest Quarter of Section 9, T2N, R32E, W.M., Umatilla County, Oregon, being more particularly described as LOTS 45 and 46 of the OVERLOOK TERRACE REPLAT, PHASE TWO recorded on June 22nd, 2017 as instrument No. 2017-6590468 in Plat Book 16, Page 47 of the Plat Records of said Umatilla County, Oregon.

Narrative of Survey

This Replat was performed at the request of Mr. Jim Hatley. The purpose of the replat was to create lots 45 through 58 as shown hereon.

All of the monumentation from Overlook Terrace Replat Phase TWO were found and held except for the most easterly monument of Lot 44 of that replat which was apparently destroyed by the construction of a retaining wall and sidewalk. That monument was replaced at the record location using the same control point for the survey as used in the prior phases. Measurements between found original monuments did deviate more than 0.06 feet from the record so the dimensions shown are being reported as record and measured from the prior

iat. This survey was performed with a Trimble R7/R8 RTK GPS system.
