



NARRATIVE

THIS SUBDIVISION REPLAT WAS MADE AT THE REQUEST OF TONI ELDER. OWNER OF THE PROPERTY TO TO REMOVE TWO ORIGINAL LOT LINES WHICH RAN THROUGH EXISTING HOUSES AND PLAT A NEW LINE WHERE EACH HOUSE COULD BE ON ITS OWN LOT AS SHOWN. LOT AND BLOCK DIMENSIONS WERE USED PER THE ORIGINAL TOWN PLAT OF ADAMS. ALL MONUMENTS FOUND AND HELD ARE NOTED.

THE SURVEY WAS MADE WITH A ONE PERSON CREW USING A LEICA GS14 REALTIME GPS RECEIVER OPERATED OVER THE ORGN GNSS NETWORK, AND A LEICA TPC 803 3" TOTAL STATION. CONTROLLING AND SET MONUMENTS WERE VERIFIED BY MULTIPLE OBSERVATIONS.
