

#### SURVEY NARRATIVE

THIS SUBDIVISION PLAT HAS BEEN PREPARED AT THE REQUEST OF SOUTH COUNTY CONSTRUCTION. THE PURPOSE IS TO DIVIDE PARCEL 1 OF PARTITION PLAT 2021-36 INTO 25 LOTS AS SHOWN HEREON. THIS SUBDIVISION HAS BEEN APPROVED BY THE CITY OF PENDLETON PLANNING COMMISSION, APPROVAL SUB 21-01.

I FOUND AND HELD ALL MONUMENTATION AS REPORTED IN PARTITION PLAT 2021-36 (R1) AND PARTITION PLAT 1998-17 (R2) TO CONTROL THE EXTERIOR BOUNDARY OF THIS PLAT. MONUMENTS AS REPORTED ON PARTITION PLAT 2021-36 WITHIN SW 18TH STREET (RAILROAD SPIKE/SCREW AND WASHER) WERE NOT FOUND IN THIS SURVEY. PLEASE REFER TO THAT PARTITION TO PERPETUATE THOSE MONUMENT LOCATIONS.

THIS SURVEY WAS PERFORMED USING TWO TOPCON HIPER LITE+ GNSS UNITS OPERATED USING RTK METHODS. THE BASIS OF BEARING IS THE CITY OF PENDLETON COORDINATE SYSTEM AS ESTABLISHED BY SITE CALIBRATION TO FOUND MONUMENTS AS SHOWN, USING COORDINATES PROVIDED BY THE CITY OF PENDLETON.
